AS THE COVID-19 PANDEMIC CONTINUED TO SPREAD GLOBALLY IN EARLY 2020, THE CEDAR CLOSED ITS PERFORMANCE HALL ON MARCH 14, 2020. WITH A REGULAR SCHEDULE OF 200+ SHOWS A YEAR, WE PROJECTED A LOSS OF OVER 70% OF OUR REVENUE STREAM. IN RESPONSE, WE LAID OFF 80% OF OUR STAFF AND CREATED A REDUCED CAPACITY PLAN WITH FOUR PART-TIME STAFF. AS THE PANDEMIC LINGERED ON AND UNCERTAINTY SET IN, CONCERNS ROSE ABOUT WHETHER LIVE MUSIC WOULD EVER RETURN TO THE WAY IT HAD BEEN. NOT ONLY DID MUSICIANS CONSIDER THE POSSIBILITY OF A BLEAK FUTURE AND CAREER CHANGES, BUT EVENT STAFF, SOUND TECHS, ROADIES, PROMOTERS, AND OTHERS PONDERED THE SAME. OUR PATRONS COULD NOT ENJOY LIVE MUSIC AND OUR HUNDREDS OF VOLUNTEERS WERE SEPARATED FROM THEIR CEDAR COMMUNITY.
