The Cedar is a nationwide leader in presenting international artists as demonstrated by the title of "Best World Music Venue in the World" according to About.com's Reader's Choice Awards. The Cedar has also become a recognized trailblazer and model for successful community engagement because of its work and adaptability in serving artists and audiences of various cultures and under-resourced communities.

The Cedar presents 250 public, all-ages concert events per year. In 2014 The Cedar hosted artist residencies that included activities such as lectures, discussions, meet-and-greets, and mini-performances on-site and in the community. Quarterly, The Cedar hosts a youth education program and

In 2014, The Cedar launched a program in partnership with Augsburg College titled Midnimo, the Somali word for unity. Midnimo consists of residencies with Somali artists who conduct activities and performances on campus and in the community. Midnimo is supported with a nationally competitive grant from Association of Performing Arts Presenters, Doris Duke Charitable Foundation, and Doris Duke Foundation for Islamic Arts that was awarded to only six organizations around the country to support efforts that increase understanding and awareness of Muslim cultures through the arts.

We saw significant impact of this program in 2014: We engaged 20 Somali**4c** (Code:) (Expenses \$ **65,677** including grants of \$ **27,000**) (Revenue \$ **7,680**)

With funding from Jerome Foundation, our competitive 416 Club Commissions program annually commissions six Minnesota-based artists to compose new work and debut it at The Cedar. The 416 Club Commissions program has proven to be a great opportunity for emerging musicians to showcase their skills and abilities through a unique, commissioned project. Commissions are based on a juried request for proposals process in which applications are reviewed by a committee of individuals from the local arts community. In 2014, the fourth round of commissions, we received more than 120 applications. The six selected artists premiered the commissions in January 2015 and saw our largest audience to date.

MN Express took five previous 416 Club Commission recipients on a ten-day tour around the state. Artists included vocalist Aby Wolf, bassist Nick Gaudette, guitarist Kyle Sobczak, fiddler Sara Pajunen, and saxophonist Nathan Hanson. At each show the artists presented a collaborative performance that included an evolved version of their commissioned works as well as new material created for the tour. In addition to scheduled, ticketed events, MN Express included pop-up performances and impromptu gigs around commercial areas, town squares, and other public spaces. This activity was made possible by the voters of Minnesota through a grant from the Minnesota State Arts Board, thanks to a legislative appropriation from the arts and culture heritage fund.
